The Grand Jury charges that Molly A. Shattuck did commit the following offenses, to wit:

COUNT 1 - RAPE THIRD DEGREE - S14- 11- 0001

MOLLY A. SHATTUCK (DOB: 2-19-1967), on or about the 31<sup>st</sup> day of August, 2014, in the County of Sussex, State of Delaware, did intentionally engage in sexual intercourse with [REDACTED] by putting her mouth on his penis and [REDACTED] had not yet reached his sixteenth birthday and the defendant was at least ten years older than [REDACTED] in violation of Title 11, Section 771(a)(1) of the Delaware Code.

COUNT 2 - RAPE THIRD DEGREE - S14- 11- 0002

MOLLY A. SHATTUCK (DOB: 2-19-1967), on or about the 31<sup>st</sup> day of August, 2014, in the County of Sussex, State of Delaware, did intentionally engage in sexual intercourse with [REDACTED] by putting her mouth on his penis and [REDACTED] had not yet reached his sixteenth birthday and the defendant was at least ten years older than [REDACTED] in violation of Title 11, Section 771(a)(1) of the Delaware Code.

**COUNT 3 - UNLAWFUL SEXUAL CONTACT SECOND DEGREE - S14- 11-0003**

MOLLY A. SHATTUCK (DOB: 2-19-1967), on or about the 31<sup>st</sup> day of August, 2014, in the County of Sussex, State of Delaware, did intentionally have sexual contact with [REDACTED] who was less than eighteen years of age, by touching his penis, in violation of Title 11, Section 768 of the Delaware Code.

**COUNT 4 - UNLAWFUL SEXUAL CONTACT SECOND DEGREE - S14- 11-0004**

MOLLY A. SHATTUCK (DOB: 2-19-1967), on or about the 31<sup>st</sup> day of August, 2014, in the County of Sussex, State of Delaware, did intentionally have sexual contact with [REDACTED] who was less than eighteen years of age, by causing or allowing [REDACTED] to touch her breast with his mouth, in violation of Title 11, Section 768 of the Delaware Code.

**COUNT 5 - UNLAWFUL SEXUAL CONTACT SECOND DEGREE - S14- 11-0005**

MOLLY A. SHATTUCK (DOB: 2-19-1967), on or about the 31<sup>st</sup> day of August, 2014, in the County of Sussex, State of Delaware, did intentionally have sexual contact with [REDACTED] who was less than eighteen years of age, by causing or allowing [REDACTED] to touch her vagina with his hand, in violation of Title 11, Section 768 of the Delaware Code.

**COUNT 6 - UNLAWFUL SEXUAL CONTACT SECOND DEGREE - S14- 11-0006**

MOLLY A. SHATTUCK (DOB: 2-19-1967), on or about the 31<sup>st</sup> day of August, 2014, in the County of Sussex, State of Delaware, did intentionally have sexual contact with [REDACTED] who was less than eighteen years of age, by causing or allowing [REDACTED] to touch her vagina with his penis, in violation of Title 11, Section 768 of the Delaware Code.

**COUNT 7 - PROVIDING ALCOHOLIC LIQUOR TO A MINOR - S14-** 11-0007

MOLLY A. SHATTUCK (DOB: 2-19-1967), between the 30<sup>th</sup> day of August, 2014 and the 31<sup>st</sup> day of August, 2014, in the County of Sussex, State of Delaware, did purchase, buy or give alcoholic liquor to [REDACTED], a person under the age of twenty-one (21) years or did knowingly allow [REDACTED] a person under her supervision and under the age of twenty-one (21) to consume alcoholic liquor, in violation of Title 4, Section 904(c) of the Delaware Code.






